- 2) Professional Sponsorship Contracts Update: Scott
 - a) Affinity Group
 Scott reported that we don't make much money.
 - b) VEO Sports Camera
 We have a \$10,000 sponsorship in the works, plus \$200 for every camera sold.
 - c) 3D NHSACA Foundational Coaching Course Scott is excited because we will make 30 dollars for every course taken.
 - d) Good Whey
 This partnership is going well, and Scott is expecting the 2nd part of \$15,000 in January.
 - e) Teal Properties Group:

It helped to get the contract amended so NHSACA does not have to share a portion of the sponsorships that we bring in. We have not had to split the recent sponsorships. The Clell Wade newsletter was good, and the second one is even better than the first. He has 80-100 people signed up for the webinars and they have been good ones. Scott – is going to Austin and will hand out sponsorship opportunities that we have available on a printed-off leaflet in the vendor hall to as many people as he can. He still has interest from the Marines. St. Joseph's is considering sponsoring us in Missouri if we were to choose to hold our convention there. Scott is excited about our sponsorships and feels that we are in a better situation than we have been in a long time.
