The meeting opened as an informational period with Darin, Dave and Ted updating both boards on the progress of the preparations for the NHSACA/NCA Convention/Clinic. Dave, Darin and Ted reviewed the following information:

- b. Silent Auction update.
- c. NHSACA Online Store update.
- d. Banquets: reported that the Great Hall is working with him and the hopes/expectations are to be able to host the banquets as planned. If not, contingency plans are made to provide an excellent Awards Program.

1. Broyles Award: High School

Dave reported that he has a zoom meeting with Scott Garvis, and Clayton and Molly Harrell concerning the Broyles Award. The original award is the very prestigious College Ass't Football COTY. Clayton and Molly run the Broyles Award and have a goal of awarding it to one high school assistant COTY in each of the 50 states. They have 7 states on board right now and are looking to see if the NHSACA would be a good match expand the number of states. A good discussion took place concerning the NHSACA's mission, financial considerations, time and effort considerations and the match with NHSACA to the Broyle's Award. It was decided that Dave would contact Clayton and Molly and direct them to Rob Younger with the High School Football Coaches Alliance as we believe this would be a better fit.

2. Finalized agreement with Varsity Bound

Dave reported that the agreement with Varsity Bound has been put into effect. The website is completed and the transition from Wix to Go Daddy is almost complete. The website looks really good and will have the capacity to include our online registration process in the future. A short discussion took place on this. 5. Conversation with Brandon Gonzalez
Dave and Ted reported on their conversation with Brandon, or Region VIII Director. Brandon said that the Southern California High School Soccer Association (B & G) want to join the NHSACA for the upcoming 2021-22 year. Also, he fully expects that the Southern California High School Boys Basketball Association will want to join at that time too. During the discussion, Brandon emphasized that these associations would like to join as separate associations.

Brandon informed Ted and Dave that California has 10 sections in the state with approximately 500 schools in each sections with 20 separate coaches' associations in each section. Only a few sports have a true state championship.

Dave reported that he reviewed the by-laws and that there do not prevent having more than one association from a state. Ted emphasized that Coaches Associations have changed over the years, and that the majority we are trying to recruit into NHSACA are single-sport associations. This will be a spring meeting agenda item.

6. D.S.A. Award
Dave reported that he has contacted the states eligible to present a D.S.A award this year and at this point Louisiana and Idaho have returned their forms. The New Jersey Football Coaches Association will be having a meeting and will get back to him on this.
